Colegiul Comisarilor Sportivi a analizat dosarele de post ale arbitrilor, carnetele de bord ale concurentilor si a decis urmatoarele:

Fapte: echipajul nr. 134– Flaviu STANCIU / Andreea STANCIU nu a pontat in CO 2C

Ofensa: Art. 19.3.1 din Regulamentul CNRB si Anexa Sanctiuni

Decizia: Penalizare 2 min in CO 2C

Motiv: Colegiul Comisarilor Sportivi a fost informat despre faptul ca echipajul nr. 134 nu a pontat in CO 2C. Dupa audierea echipajului, s-a observat faptul ca echipajul nu a ramas in service si s-a indreptat direct spre parcul inchis. Au fost audiati atat membrii echipajului, cat si arbitrii din posturile CO 2B si CO 2C. Comisarii Sportivi au stabilit faptul ca a fost o greseala din partea echipajului, astfel incat pentru nerespectarea ordinii controalelor orare se aplica o penalizare de 2 minute echipajului nr. 134.

Dreptul de a face apel la această Decizie este prevăzut Art.15 din Regulamentul particular.

The Stewards of the Meeting have studied the marshals reports and the boarding cards of competitors and have decided the following:

Facts: crew. No. 134 – Flaviu STANCIU / Andreea STANCIU did not check in TC 2C

Offense: Art. 19.3.1 in CNRB and the Sanctions Appendix

Decision: Penalty 2 min in CO 2C

Reason: *The Stewards of the Meeting were informed about the fact that crew no. 134 did not check in TC 2C. After hearing the crew, the Stewards noticed that the crew did not remain in the Service Park and left straight to the parc ferme. Both crew members and marshals in TC 2B and TC2C have been heard. The Stewards have decided that it was a crew mistake. Therefore, for not following the timed control order, the Stewards apply a penalty of 2 minutes to crew no. 134.*

Competitors have the right to appeal to this Decision in accordance with Article 15 of the Supplementary Regulations.
